- Implemented new World Hcp System and saw a record number of scores posted. Thank you.
- Created a CCC tri fold flyer to advertise and attract new members. (Available in Pro-Shop)
- Completed structural repairs to pool and successful opened it despite a delay because of COVID.

As most of you know there has been quite a bit of work going on with the ponds on the course. A lot of progress has been made. To date they still need to run the big drain line down to the other side of number 7. All the dirt on the upper side will have to cure for probably a year, then they will move it and start on the top pond. This work is being done on the ponds to improve the course.

This work will keep more water off the course. The bigger drain being installed will allow water to run off quicker and the ponds will have a larger capacity.
